(further DEVELOPER), located in Nizhny Novgorod, Russia and distributed worldwide by Woodlandia Corp. (further DISTRIBUTOR), located in Richmond Hill, Ontario, Canada.

By downloading, installing or using this computer software or any portion thereof ("SOFTWARE") you agree to the following terms and conditions (the "Terms and Conditions"). The SOFTWARE, and any portion thereof, are referred to herein as the "Software." By agreeing to these Terms and Conditions, you represent that you are 18 years old or older and capable of entering into a legally binding agreement. These Terms and Conditions and the relationship between you and DISTRIBUTOR shall be governed by the laws of the Province of Ontario, Canada without regard to its conflict of law provisions.
- c) Waiver and Severability of Terms. The failure of DEVELOPER or DISTRIBUTOR to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of such right or provision. If any provision of these Terms and Conditions is found by a court of competent jurisdiction to be invalid, the parties nevertheless agree that the court should endeavor to give effect to the parties' intentions as reflected in the provision, and the other provisions of these Terms and Conditions shall remain in full force and effect.
